In an effort to foster South Tahoe Association of REALTORS® member involvement in the decision making process, the Election Committee requests your input concerning the selection of nominees. In accordance with our Bylaws: *"The Election Committee shall circulate a notice to all members that they may request nomination at least two weeks prior to the committee's selection of nominees."*

*"The Nominating Committee shall select **at least one** candidate for each office, **except President**, and **at least one** candidate for each place to be filled on the Board of Directors."*

The Board of Directors is comprised *"of four (4) officers and nine (9) directors. The ninth (9th) director shall be the most immediate past President. ... No more than three officers and/or directors may be elected from one firm. ... In the event that an elected director or officer changes firms after an election and in so doing, increases that firm's director/officer count to more than three (3), it is hereby established that each officer/director will be allowed to complete his/her term."*
