The Election Committee has set *Tuesday, November 18, 2014 as the date for the 2015 Election*. The nominating committee has met, and with the assistance of recommendations from members has determined a slate.

According to the South Tahoe Association of REALTORS® Bylaws: *"The Nominating Committee shall select at least one candidate for each office, except President, and at least one candidate for each place to be filled on the Board of Directors. ... The report of the nominating committee shall be distributed to each member eligible to vote at least four (4) weeks preceding the election."*

The Board of Directors is comprised *"of four (4) officers and nine (9) directors. The ninth (9th) director shall be the most immediate Past President. ... No more than three officers and/or directors may be elected from one firm. ... In the event that an elected director or officer changes firms after an election and in so doing, increases that firm's director/officer count to more than three (3), it is hereby established that each officer/director will be allowed to complete his/her term."*
